- Selling and Administration Expenses was decreased by 3%. There was decreased in part of

administrative expense, mainly.

- Interest Expense was decreased by 6% from Q3/2018. There is the effective of cash flow

management by balancing between accounts receivable and accounts payable, including the decreasing of

long term loan.

For the separate company statement has total revenue 104.08 Million Baht and net profit 4.95 Million Baht in

the separate financial statement for the year 2019 ended September 30, 2019, compared with the same

period, year 2018 ended September 30, 2018, which had total revenue 112.77 Million Baht and net profit 7.47

Million Baht. This is the result of the efficiency of administrative expenses management.
