Subject: Report on Progress of the Company Dispute

To: The President

The Stock Exchange of Thailand

Reference: Document No. 0374-2023 in the Company Dispute

According to CMO Public Company Limited (the "Company") Information Disclosure No. 0374-2023 dated November 13, 2023, regarding the notification of significant legal disputes, the Company would like to update the progress of the significant legal disputes involving the Company and its subsidiaries as follows:

1. A criminal case to the Central Criminal Court for Corruption and Misconduct Cases. It appeared as a black case number between prosecutors at AorTor 213/2023—office of the Special Prosecutor for Anti-Corruption 1 Litigation, Plaintiff and CMO Public Company Limited, Defendant.

In the court proceedings, the Company submitted a defense statement presenting the same facts and reasoning as those provided while submitting counterarguments to the NACC (National Anti-Corruption Commission). The court scheduled a witness examination for July 1 7, 2 0 2 4, during which the Company successfully presented its witnesses. Subsequently, the court has scheduled the delivery of the judgment for September 24, 2024.

2. On 15 September 2023, a supplier's company, as the plaintiff filed a lawsuit in the civil court alleging that a subsidiary, as the defendant, failure to pay for design and public relations planning services that the plaintiff has performed. The plaintiff demanded to pay such service amounting to Baht 1.28 million with interest at the rate of 5% per annum.

On July 1 2, 2 0 2 4, the Company successfully presented its witnesses as scheduled. The court has subsequently ordered that the judgment be delivered on August 22, 2024.



3. On 18 September 2023, a supplier's company, as the plaintiff, filed a lawsuit in the civil court alleging that a subsidiary, as the defendant, breached the service contract. The plaintiff demanded to pay such service amounting to Baht 0.53 million with interest at the rate of 5% per annum.

On August 9, 2024, the Company successfully presented its witnesses as scheduled. The court has subsequently ordered that the judgment be delivered on October 10, 2024.

4. On 31 October 2023, a supplier's company, filed a lawsuit in the civil court alleging that a subsidiary, breached the contract for area service. The plaintiff demanded to pay penalty according such contract amounting to Baht 2.07 million with interest at the rate of 5% per annum.

On July 26, 2024, the Company presented witnesses for examination as scheduled. The court has kindly set a date for the judgment to be pronounced on September 9, 2024.

5. The Dispute between the Company and Advance Opportunities Fund ("AO Fund") and Advance Opportunities Fund 1 ("AO Fund 1")

On March 15, 2024, Advance Opportunity Fund Co., Ltd., as the petitioner, filed a request with the Civil Court to enforce the arbitral award from Singapore. The Civil Court scheduled a hearing for May 20, 2024. When the date arrived, the Company requested an extension for filing objections, which the court granted until June 20, 2024, and rescheduled the hearing to July 8, 2024.

When the hearing date arrived on July 8, 2024, the Company requested the court to consider the issue of jurisdiction, as the Company believed that the case fell under the jurisdiction of the Central Intellectual Property and International Trade Court. The court then ordered that the case documents be sent to the President of the Court of Appeals for Special Cases for consideration and that proceedings be temporarily suspended pending the outcome of this review. A hearing to consider this matter was scheduled for October 21, 2024.
