Subject : Report on Progress of the Company Dispute

To : The President

Reference : Document No. 0239-2024 in the Company Dispute

According to CMO Public Company Limited (the “**Company**”) Information Disclosure No. 0239-2024 dated August 14, 2024, regarding the notification of significant legal disputes, the Company would like to update the progress of the significant legal disputes involving the Company and its subsidiaries as follows:

1. A criminal case to the Central Criminal Court for Corruption and Misconduct Cases. It appeared as a black case number between prosecutors at AorTor 213/2023—office of the Special Prosecutor for Anti-Corruption 1 Litigation, Plaintiff and CMO Public Company Limited, Defendant.

On September 24, 2024, the court convened to deliver its judgment, ruling in favor of dismissing the plaintiff's claims. Subsequently, the plaintiff, represented by the public prosecutor, submitted a second motion requesting permission to extend the time for filing an appeal. Should an appeal be filed, the Company will submit a counter-appeal for consideration by the appellate court.

2. On 15 September 2023, a supplier's company, as the plaintiff filed a lawsuit in the civil court alleging that a subsidiary, as the defendant, failure to pay for design and public relations planning services that the plaintiff has performed. The plaintiff demanded to pay such service amounting to Baht 1.28 million with interest at the rate of 5% per annum.

On August 22, 2024, the court rendered its judgment, dismissing the plaintiff's claim. Subsequently, as neither party filed an appeal, the case was deemed final.

3. On 18 September 2023, a supplier's company, as the plaintiff, filed a lawsuit in the civil court alleging that a subsidiary, as the defendant, breached the service contract. The plaintiff demanded to pay such service amounting to Baht 0.53 million with interest at the rate of 5% per annum.

On October 10, 2024, the court delivered its judgment, ordering the defendant to pay THB 469,612 with interest at the rate of 5% per annum on the principal amount, starting from the day following the filing date (September 18, 2023) until full payment is made to the plaintiff. Additionally, the defendant was ordered to cover the court fees on behalf of the plaintiff, with attorney fees set at THB 8,000. Other claims were dismissed, and each party was to bear their litigation expenses. The defendant's counterclaim was dismissed, and the court fees and litigation expenses related to the counterclaim were to be borne individually.

The subsidiary, as the defendant, will proceed to file an appeal against the lower court's judgment with the Court of Appeal.

4. On 31 October 2023, a supplier's company, filed a lawsuit in the civil court alleging that a subsidiary, breached the contract for area service. The plaintiff demanded to pay penalty according such contract amounting to Baht 2.07 million with interest at the rate of 5% per annum.

On September 9, 2024, the court delivered its judgment, ruling that the defendant must pay the plaintiff the amount of 1,176,000 THB along with interest at a rate of 5% per annum on the principal amount from the filing date until full payment is made to the plaintiff. Additionally, the court ordered the defendant to cover the court fees on behalf of the plaintiff, with attorney fees set at 5,000 THB and litigation expenses at 3,000 THB. All other requests were dismissed.

The subsidiary, as the defendant, will proceed to file an appeal against the lower court's judgment with the Court of Appeal.

5. The Dispute between the Company and Advance Opportunities Fund (“AO Fund”) and Advance Opportunities Fund 1 (“AO Fund 1”)

On October 21, 2024, the Civil Court delivered the decision of the President of the Specialized Court of Appeal to the parties. The President of the Specialized Court of Appeal determined that this case falls under the jurisdiction of the Central Intellectual Property and International Trade Court.

The Civil Court has, therefore, ordered the compilation of case records and documents to be forwarded to the Central Intellectual Property and International Trade Court for scheduling a hearing and notifying the parties accordingly.

If there is any further progress, the Company will immediately notify SET upon further progress.
